





Please refer to letter no. NIL dated NIL on the subject cited above.

After minutely scrutinizing the recommendations made by District Education Officer, Jullundur and the DPI Private Aided (School) and the documents produced by the Management of the school alongwith its affidavit, a No Objection Certificate from the Government is issued on the following conditions.

1. That in future if on any complaint/inspection it comes to the notice that in obtaining the No Objection Certificate from the Government you have applied for on wrong facts/ or you have not complied with the directions issued by the Punjab Government from time to time, and the conditions mentioned in your affidavit are not being complied with, in that case the No Objection Certificate will be withdrawn at any time.
2. It will be mandatory that arrangement for teaching the subject of Punjabi upto 10th class in your school is made properly, and the CBSE New Delhi will take steps for holding an examination of Punjabi in such schools. It is also pointed out that on any violation of the conditions prescribed, the No Objection Certificate issued here shall stand withdrawn forth with.
3. After affiliation with the CBSE, the Management of the school will be bound to give its staff, pay and other emoluments at par with Government employees. In case of its non compliance, the No Objection Certificate issued here will be withdrawn.
- 4 That yourself and your Management shall ensure that any information sought by the District Education Officer, Jullundur or any Senior Officer of the Education Department shall be supplied immediately and necessary assistance will also be provided to these officers.

Recognition certificate for the school under sub-rule (4) of rule 11 of right of Children to free and Compulsory Education rules, 2011 for the purpose of section 18 of Right of Children to Free and Compulsory Education act, 2009.

Dear Sir/Madam,

With reference to your application dated 2021 and subsequent correspondence with the school/ inspection in this regard, I convey the grant of provisional recognition **SWAMI MOHAN DASS MODEL SCHOOL, BABA MOHAN DASS NAGAR, BEHIND VERKA PLANT, JALANDHAR** for the Class 1<sup>st</sup> TO 2<sup>nd</sup> for a period i.e 01.04.2022 TILL 31.03.2025.

The above sanction is subject to the fulfillment of the following condition, namely: -

1. The grant for recognition is not extendable and does not in any imply any obligation to recognize/affiliate beyond class VIII.
2. The school shall abide by the provision of the Right of Children to Free and Compulsory Education Act 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II)
3. The school shall admit in class 1, to the extent of 25% of the strength of that class, children belonging to the weaker section and the disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion:  
Provided, that in case of pre-primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the school shall be reimbursed as a per sub-section 2 of section 12 of the Act. To receive such reimbursement, the school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any Screening Procedure.
6. The school shall not deny admission:
  - a) To any child for lack of age proof; or
  - b) If such admission is sought subsequent to the extended period prescribed period prescribed for admission; or
  - c) On the ground of religion, caste or race, place of birth or any of these reasons.
7. The school shall ensure that: -
  - a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary Education in a school;
  - b) no child shall be subjected to physical punishment or mental harassment;
  - c) no child is required to pass any board examination till the completion of elementary education;
  - d) every child completing elementary education shall be awarded a certificate as laid down under rule 21;
  - e) Inclusion of students with disabilities/ special needs as per the provision of the Act:
    - f) the teachers are recruited with minimum qualifications, as laid under sub-section (1) of section 23; provided that the existing teachers who, at the time of commencement of the Act, do not possess the minimum qualifications, shall acquire such qualifications within a period of 5 years from the date of commencement of the Act. (Which has been extended up to 31.03.2019 as per amendment in RTE Act 2009.)

h) the teachers shall not engage himself or herself in any private teaching activities.
8. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
  9. The school shall enroll students proportionate to the norms and standards available in the school as specified in section 19 of the Act.
  10. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection, if made, are as given under: -
